Bid is open to all eligible Bidders.
- 2. The **Naugaad RM, Darchula** invites sealed bids submitted manually from eligible contractors for the construction of Road Bridge Building as mentioned below in the table under National Competitive Bidding procedures.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Naugaad RM, Darchula.
- 4. A complete set of Bidding Documents may be purchased from the **Naugaad RM office Hoparigaad Darchula** by eligible Bidders on the submission of a written application, along with the notarized copy of company/firm registration certificate, tax clearance letter of FY 2074/2075 and upon payment of a non-refundable fee of amount and till date March 21, 2019 (Chaitra 07, 2075).
- 5. Sealed bids must be submitted to the office of **Naugaad RM Hoparigaad**, **Darchula** by hand/courier on or before 12:00 hrs on March 22, 2019 (Chaitra 08, 2075). Bids received after this deadline shall not be accepted.
- 6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on March 22, 2019 (Falgun 08, 2075) at the office of **Naugaad RM office Hoparigaad Darchula**.
- 7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Naugaad RM Darchula deposit Account No. (Ga-4-1)-4090303007108 at Rastriya Banijya Bank, Darchula and submit the receipt of the deposited amount of cash along with the bid. If submission & Opening falls on holiday then next day shall be considered the deadline.
