4. Pre-bid meeting shall be held at Naugad Rural Municipality Naugad Hoparigad Darchula Sudurpashchim Province Nepal at January 22, 2026 17:00 hours.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before February 8, 2026 12:00 Noon. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of the Bidders' representatives who choose to attend on February 8, 2026 at 14:00 hours (2:00 PM) at the office of Naugad Rural Municipality, Naugad Hoparigad, Darchula, Sudurpashchim Province, Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or, in case of e-bidding, a scanned copy of the bid security in PDF format, amounting to a minimum of NRs. 1,40,000. The bid security shall be valid for 120 days, i.e., 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
