3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Naugaad RM, Darchula**.
4. A complete set of Bidding Documents may be purchased from the **Naugaad RM office Hoparigaad Darchula** by eligible Bidders on the submission of a written application, along with the notarized copy of company/firm registration certificate, tax clearance letter of FY 2074/2075 and upon deposition of a non-refundable fee of specified amount in the bank account of **Naugaad Rural Municipality (Mul Sanchit Kos Khata Ga-4-1) 120009065298501 (Janata Bank Darchula)** till date **April 17, 2019 (Baishakh 04, 2076)**.
5. Sealed bids must be submitted to the office of **Naugaad RM Hoparigaad, Darchula** by hand/courier on or before 12:00 hrs. on **April 18, 2019 (Baishakh 05, 2076)**. Bids received after this deadline shall not be accepted.
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs. **on April 18, 2019 (Baishakh 04 2076)** at the office of **Naugaad RM office Hoparigaad Darchula**.

If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Naugaad RM Darchula Dharauti Account No. (Ga-3)-120009065298504** at Janata Bank, Darchula and submit the receipt of the deposited amount of cash along with the bid. If submission & Opening falls on holiday then next day shall be considered the deadline.
